

**Terms and Conditions of Promotional Event**  
**“DEVELOP ALL-ROUND WITH MULTISPORT BOOKS!”**

**§ 1**

**DEFINITIONS**

The terms used in these Terms and Conditions shall mean as follows:

1. **Promotional Event** – marketing campaign conducted by the Organizer in accordance with the rules specified in these Terms and Conditions in the Multisport Zone at: <https://www.kartamultisport.pl/> from March 1, 2018, at 08:00 am, to May 31, 2019, at 11:59 pm, as: “DEVELOP ALL-ROUND WITH MULTISPORT BOOKS!”, addressed to individuals in accordance with the rules covered by these Terms and Conditions,
2. **Organizer** – Benefit Systems Spółka Akcyjna, with its registered office in Warsaw at: Plac Europejski 2, 00-844 Warszawa, registered by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division under KRS number: 0000370919, Tax Identification Number (NIP): 836-16-76-510, Business Statistical Number (REGON) 750721670,
3. **Partner** – AUDIOTEKA S.A., with its registered office in Warsaw, 02-673, ul. Konstruktorska 12, registered at the District Court for the Capital City of Warsaw in Warsaw, 13th Commercial Division of the National Court Register under number 0000305704, REGON: 141438454, NIP: 521-36-18-086.
4. **Service** – website maintained by the Partner and related to the LECTON System through which it provides services as part of the LECTON System in accordance with the rules provided for in these Terms and Conditions, available at [www.lectonapp.com](http://www.lectonapp.com),
5. **LECTON System** – LECTON software developed by the Partner, consisting of the online Service and the LECTON mobile app, used by users in order to enjoy paid and free services rendered electronically by the Partner,
6. **LECTON System Terms and Conditions** – terms and conditions of use of the LECTON system available at <https://lectonapp.com/>
7. **Active Card** – an active sports card issued by the Organizer as a part of the MultiSport Program, enabling Promotional Event Participants to participate in the Promotional Event, provided that the requirements set forth in the MultiSport Zone are met. Active Cards that entitle the Promotional Event Participant to take part in the Promotional Event include the following employee cards or cards for an accompanying person entered by the employee in the Multisport Program (including Kids and Senior Cards): MultiSport Plus, MultiSport Classic, MultiActive,
8. **Promotional Event Participant** (also called Participant) – an individual who has an Active Card and an account in the Multisport Zone,
9. **Works** – works (including but not limited to recordings and other multimedia content) made available by the Partner to the Promotional Event Participants within the LECTON System in accordance with the provisions of the Terms and Conditions available at <https://lectonapp.com/>,
10. **Promotional Code** – an electronic code consisting of a unique string of characters which, when entered in the LECTON System, in the “Promotional Code” box, in the “Your Profile” tab, will provide the User with a free 90-day access to a subscription service in the LECTON System (offered to other users against

- payment), as per the provisions of these Terms and Conditions,
11. **Application** – LECTON mobile app related to the LECTON System through which the Partner renders services described in these Terms and Conditions on mobile devices, including but not limited to smartphones and tablets, available for installation via Google Play and Apple iTunes via links published on <http://lectonapp.com/pl/>, running on Android 5.0+ and iOS 10.0+ devices.

## § 2

### GENERAL PROVISIONS

1. The Promotional Event takes place within the territory of the Republic of Poland between March 1, 2019 and May 31, 2019, with the reservation that every Active Card with such data as first name, last name and card number, which are necessary to receive a total maximum of 1 Promotional Code, entitles the Participant to receive a free 90-day access to the paid subscription service in the LECTON System. Between March 1, 2019 and May 31, 2019, a maximum of 1 individual Promotional Code for a free 90-day access to the paid subscription service in the LECTON System can be received using an Active MultiSport Card after signing in to <https://www.kartamultisport.pl/>
2. Participating in this Promotional Event and using the Promotional Code requires the Participant to:
  - a) register or have an existing account in the Partner's service (LECTON System),
  - b) have an existing account and an Active Card in the <https://www.kartamultisport.pl/> service,
  - c) conclude with the Partner a services agreement and the relevant licensing agreements in accordance with the LECTON System Terms and Conditions, enter the Promotional Code in the correct box in the LECTON System,
  - d) express his/her consent to the provisions of these Terms and Conditions,
  - e) download and install the free LECTON application on his/her smartphone or tablet (systems: Android 5.0 and newer and iOS 10.0 and newer).
3. The Promotional Event shall be held under the rules and provisions outlined in these Terms and Conditions. When enrolling for the Promotional Event, the Participant acknowledges that he or she is aware of the applicable rules and consents to being bound by the Terms and Conditions.

## § 3

### RULES OF PARTICIPATION

1. In order to obtain one Promotional Code entitling to a free 90-day access to the subscription service in the LECTON System, the Participant should:
  - a) sign in on [www.kartamultisport.pl](http://www.kartamultisport.pl), go to the [www.kartamultisport.pl/en/service/multisport-books](http://www.kartamultisport.pl/en/service/multisport-books) and click "Generate code" and accept the Terms and Conditions of the Promotional Event,
  - b) go to <https://promo.lectonapp.com>,
  - c) sign in to the Participant's account held with the LECTON System or register a new account in the LECTON System by providing an e-mail address and a selected password. In order to register a new account, the Participant will need to accept the LECTON System Terms and Conditions available in the registration form;
  - d) After signing in or registering a new account in the LECTON System, select the box for the Promotional Code and confirm with the "Next" button;

- e) Accept the offer of paid subscription service in the LECTON System presented, which is made available free of charge on the basis of the Promotional Code provided, by tapping the “Activate” button;
  - f) Download and install the Lecton Application that works on devices with Android 5.0 and newer and iOS 10.0 and newer (Internet address that allows for installing the Lecton application is available at <http://www.lectonapp.com/pl/>);
  - g) After installing the Lecton application, sign in with the same data (e-mail address and password) that were entered during the activation of the paid subscription in the LECTON System, with the Promotional Code.
2. Listening to Works available in the LECTON System can only be done through the Lecton Application.
  3. The contents available in the Lecton Application cannot be downloaded as a separate file.
  4. One Promotional Code enables the Promotional Event Participant to activate a free 90-day access to the paid subscription of the LECTON System.
  5. The generated Promotional Code is not subject to exchange for cash or any other item.
  6. The Promotional Code obtained during the Promotional Event can be used until May 31, 2019. After this date, the Promotional Code will be deactivated and will no longer entitle the Participant to activate a free 90-day access to the paid subscription of the LECTON System.
  7. The Participant is entitled to withdraw from the agreement in line with the provisions of the LECTON System Terms and Conditions. In cases not covered by these Terms and Conditions, the provisions of the LECTON System Terms and Conditions shall apply.

#### § 4

#### COMPLAINTS

1. All complaints regarding the way the Promotional Event is conducted by the Partner as regards the activities performed by a Promotional Event Participant carried out in the LECTON System can be reported by e-mail at [bok@benefitsystems.pl](mailto:bok@benefitsystems.pl) while the Promotional Event lasts and within 30 days after it.
2. Complaints referred to in subsection 1 above should contain the first name, last name, e-mail address for contact concerning the application, MultiSport Plus, MultiSport Classic or MultiActive card number used to generate the Promotional Code, the Promotional Code used for activation of a free 30-day access to the paid subscription of the LECTON System, as well as a detailed description and reason for the complaint.
3. Complaints shall be examined by the Organizer within 14 days of their receipt.
4. Complaints regarding the manner in which the Lecton System is operated by the Partner as regards the activities performed by a Promotional Event Participant shall be examined by the Partner in accordance with the rules and in the manner indicated in the LECTON System Terms and Conditions.
5. The Partner shall examine complaints based on these Terms and Conditions.
6. The Promotional Event Participant shall be notified about the outcome of his/her complaint to the Partner by an e-mail sent to the address provided by the Participant in his/her complaint.
7. After the complaint procedure is exhausted, the Participant shall be entitled to pursue unaddressed claims before a locally competent ordinary court.
8. The Promotional Event Participant shall be entitled to consider his/her complaints and pursue claims out of court. Should the Participant wish to pursue amicable resolution of disputes regarding online

shopping, he/she can file his/her complaint using the EU ODR internet platform available at <http://ec.europa.eu/consumers/odr/>.

## § 5

### PERSONAL DATA

1. The Promotional Event Participant, by participating in the Promotion and registering in the LECTON System as per the provisions of these Terms and Conditions, consents to the processing of his/her personal data by the Partner as personal data controller, as per the provisions of the LECTON System Terms and Conditions.

## § 6

### FINAL PROVISIONS

1. By participating in the Promotional Event, the Promotional Event Participant confirms that he/she meets all the requirements for participating in the Promotional Event and consents to participate in the Promotional Event in line with the provisions of these Terms and Conditions. In particular, the Promotional Event Participant undertakes not to interfere with the Promotional Event in a way that is against these Terms and Conditions and that intrudes upon the course of this Promotional Event as intended by the Organizer.
2. The Partner makes the reservation that, in order to participate in the Promotional Event and use the LECTON System it may be necessary to connect to a telecommunications network, which may result in data transmission, for which the Participant may be charged by his/her telecommunications operator, as per the operator's price list.
3. The Partner shall have the right to exclude a Participant from the Promotional Event if the Participant breaches any provision of these Terms and Conditions, including when the Participant interferes with the mechanisms of the Promotional Event.
4. The Partner shall have the right to exclude a Participant from the Promotional Event if the Participant breaches any provision of the LECTON System Terms and Conditions, including when the Promotional Event Participant interferes with the mechanisms of the Promotional Event.
5. The Partner reserves the right to amend the provisions of the Promotional Event Terms and Conditions, as long as such amendments do not result in the deterioration of the conditions of participating in the Promotional Event, and preserve the Promotional Event Participants' acquired rights. Amendments to the Terms and Conditions shall be available at: [www.kartamultisport.pl/mój-profil](http://www.kartamultisport.pl/mój-profil). When the Promotional Event Participant does not accept the amendments to these Terms and Conditions, the Participant has the right to withdraw from participating in the Promotional Event.
6. The Partner shall not be responsible for:
  - a) Failure to perform services covered by this Promotional Event caused by the Promotional Event Participant supplying incorrect or insufficient data;
  - b) The Participant not possessing a device that can support the LECTON System.
7. These Terms and Conditions shall be made available to all Promotional Event Participants in the Partner's offices as well as during the Promotional Event, that is between 3/01/2019 and 5/31/2019 and for 30 days after that period, and at [www.kartamultisport.pl/regulaminy](http://www.kartamultisport.pl/regulaminy) in a way that enables users to acquire, recreate and record their contents.

8. An abbreviated description of the manner in which the Promotional Event will be held is included in marketing and information materials accompanying the Promotional Event. All contents of these materials are supplied for informational purposes only. Only the provisions of these Terms and Conditions shall be binding.
9. The obligations resulting from these Terms and Conditions shall be governed by the provisions of the Polish law.
10. Matters not covered by these Terms and Conditions shall be governed by the provisions of the Civil Code as well as the Act on Rendering Electronic Services of July 18, 2002 (Dz.U. (Journal of Laws) No. 144, item 1204, as amended).
11. This Promotional Event is not a game of chance, prize draw, mutual betting or a promotional lottery the outcome of which is based on chance (random drawing) within the meaning of the Gambling Act of November 19, 2009 consolidated text: Journal of Laws of 2009, No. 201, item 1540).
